**Terms and Conditions**

**TENURE:** Unless utilised, all Reservations are subject to a 15-year tenure and this tenure is renewable. After a period of 15 years, should the Interment Rights have not been utilised and or Tenure not been renewed, the Tenure shall lapse.

**COSTS:** Costs for Burial and Headstone are separate expenses at the time of interment.

**APPROVED WORKS:** All memorials must be approved by the Kandanga Cemetery Association. Sections C & D, all memorials must be arranged through the Association and external suppliers are not permitted.

**BURIAL RIGHTS:** The applicant is recorded as the Burial Rights Holder for the allocated plot or niche and may authorise interment or inurnment in accordance with Cemetery guidelines and agreements. After the interment of the Burial Rights holder, the Burial Rights become part of the holders 'estate' and are dealt with under the Qld Succession Law.

Burial Rights Certificate will be issued for the reservation once fees are paid.

Burial Rights may be transferred on approval of Kandanga Cemetery Association

Burial Rights may be surrendered to Kandanga Cemetery Association at the value paid\*.

Kandanga Cemetery Association's Price Schedule is reviewed annual on the 1st of January.
